

SCOOTER LEASE AGREEMENT

In Donostia on July XX , 2023

Joined by Mr./ Mrs _____, of legal age, domiciled in _____, and driver's license _____, as LESSEE / DRIVER.

And on the other, DONOSTIMOTORENT, with address in Donostia (Gipuzkoa) Avda. Madrid 18 basement 9, with DNI 34.106.419-H as LESSOR (owner)

DECLARE

FIRST.- That DONOSTIMOTORENT is the owner of the WOTTAN 125 STORM scooter with registration number _____ that is the object of this lease.

SECOND.- That Mr./Mrs. _____, is interested in renting said scooter, which he claims to know and finds suitable for the purpose of the contract,

THIRD.- Both parties decide to carry out this SCOOTER LEASE AGREEMENT, based on the following:

CLAUSES

1.- The motorcycle is delivered at _____ a.m. on July ____, 2023 and must be returned at ____ a.m. on July ____, 2023

2.- The lessee claims to be over 25 years of age and have a valid European driving license suitable for driving scooters, that is, an A1 or B license with 3 years of experience.

3.- PRICE

The fixed price for 24 hours is €55 to be paid in cash, bizum or by credit card.

This price includes the scooter, 2 jet helmets, trunk and mobile phone holder.

Third party insurance.

Unlimited kilometers.

Roadside assistance

Personal delivery of the scooters.

4.- DEPOSIT

A deposit of €250 will be withheld via credit card or cash in order to compensate for any damage caused to the motorcycle, which will be returned upon delivery of the vehicle if it is in correct condition.

5.- DELIVERY OF THE MOTORCYCLE

5.1 The scooter is delivered with a full tank of gasoline and must be returned with a full tank.

In the event that the tank is not delivered full, 5 euros per line will be charged + 25 € for refueling costs.

5.2 If the motorcycle is delivered later than the stipulated time, €30 per hour of delay will be charged.

5.3 In case of loss or breakage of material (mirror, turn signals, keys, helmet, trunk, etc.), the amount of 50 euros for each concept will be withheld from the deposit.

5.4 In the event of scratches on the vehicle, an amount of €150 will be withheld.

6.- INSURANCE

The insurance is to third parties, therefore it will cover the damages generated to a third party but not the own damages to the vehicle. In case of having an incident, blow or accident attributable to the lessee or in case of being under the influence of alcohol or drugs, the insurance will not be responsible for the damages caused and the corresponding amount of the deposit will be withheld.

The property will not be held responsible under any circumstances for personal damage generated by the user to third parties, whether it be run over, blows, etc. and what could be derived from it.

And as proof of their agreement, both parties sign and initial it in duplicate on all pages in the place and on the date indicated in the heading.
